- 2003 California: For complex data system integration and EBT statewide rollout.
- 2004 Florida: For size and complexity of the project and the conference was in Florida that year.
- 2005 Louisiana: For disaster relief during Hurricane Katrina.
- 2006 Texas & New Mexico: For validating a cost-sharing commercial model for WIC EBT.
- 2007 Iowa DHS: For promotion of farmers market EBT.
- 2008 Florida: Disaster buddy system back up program. First two time winner.
- 2009 Michigan WIC: First statewide online WIC EBT system
